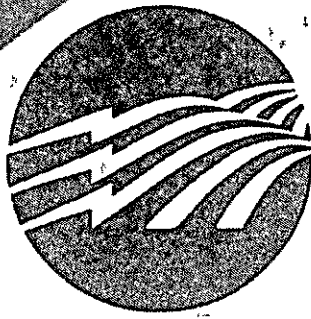

Three Rivers Electric Cooperative's Gilbert G. Hilkemeyer Scholarship

Three Rivers Electric Cooperative is pleased to announce the application process for the Gilbert G. Hilkemeyer Scholarship. Established in 1991 in honor of former General Manager Gilbert Hilkemeyer, the scholarship provides financial assistance to students within Three Rivers Electric Cooperative's service area who plan to attend college or pursue training at a vocational institution.

Eligible schools include public and private colleges, junior colleges, and vocational institutions within the State of Missouri.

Five \$2,000 scholarships will be awarded. Recipients will receive their scholarship checks at Three Rivers Electric Cooperative's Annual Meeting on the first Friday in August.

A three-person scholarship committee will review all completed applications, conduct interviews with finalists, and select recipients based on interview performance, grade point average, ACT scores, and involvement in school, church, and community activities.

Three Letters of Recommendation Required

Three letters of recommendation must be submitted with the completed application. Applicants are responsible for ensuring all three letters are received by the application deadline. Applicants should select individuals who can speak to their character, accomplishments, work ethic, and involvement in their school or community.

Eligible applicants are high school seniors whose parents or guardians are members of Three Rivers Electric Cooperative.

The application must be completed in its entirety and submitted with all required supporting materials, including three letters of recommendation, to:
